:THEME:

IF A COMMON MAN BECOMES THE PRIME MINISTER.
(NATIONAL SHORT FILM COMPETITION)

INTRODUCTION: -

A Unique Short Film-making competition has been designed on an uncommon theme, i.e.

“If a common man becomes the Prime Minister” by Academy of Cultural Activities and Art Institute(Trust) in collaboration with Dream Works Digital Studio (Multimedia Production House).

THE SEED OF THOUGHT:

India is proceeding on the path of progress and development, and marching towards the goal of becoming a superpower. In the wake of such a situation, what would you do as a common man if you get a chance to become the Prime Minister of India? Suppose, you are on the chair of the P.M, what sort of transformation or desired change can you bring in our country? This is very idea that clicked in our mind and we invite your creativity in making a 10-minute short film (1280x720p HD MP4) and take part in this unique competition.

We intend to develop a bridge between the common man (CM) and the PM to communicate his creative ideas through art. The PM also may have his glance at this gesture and can know what a common man thinks about various avenues of development, such as education, entrepreneurship, Industry, Agriculture, Infrastructure, Governance etc. by which we may lead our nation to the statue of a super power in the world.

SUBJECTS OF THE COMPETITION.

1. Development of the Nation
2. Economic Super Power
3. Good Standard of Living For a Common Man
4. Basic Facilities
5. Participant's own ideas
6. Eradication of corruption
7. Good Governance

In addition to the above topics, the participants may present his innovative ideas on the topics of his choice, through which we may proceed to the destination of a developed country. The Organizing Committee would welcome such ideas.

RULES OF THE COMPETITION: -

- (1) Any citizen of India (or NRI) can take part in this competition and duration of the short film should be minimum 1 min and should not exceed 10 min and the format of the short film should be 1280 720p HD MP4.
- (2) Any student, collegian or any (NRI) can take part in the contest, irrespective of his/her age.
- (3) We shall try to present the top 10 winning films of this Competition before Prime Minister Mr. NarenndrabhaiModi.
- (4) Jury of the short film competition shall include renowned artists of India, experts and celebrities from the film world.
- (5) The aim of this contest is non-commercial, It is to provide a platform to the citizens and make India shining.
- (6) Registration Fees: (Non – Refundable)
For Students: - Rs 1000/-
For Non – Students: - Rs 1500/-

- (7) Participants have to complete the film within one month of the confirmation of your registration.
- (8) The desirous participants should go for Online Registration, and submit the fees through DD/Charge Cheque of Bank of India, favoring Dream works the Digital studio”

- (11) Participants should send their films DVD with the entry fess, or if you have paid the registration fee online, the Xerox of the same along with application form.
- (12) The competition is based on “ No Profit, No loss Basis” and the Entry Fees (Registration Fees) will be utilized in the management of the competition.
- (13) Within one month of the competition of your registration you have to submit the film.
- (14) The participant’s should keep the title of their film as – “IF A COMMON MAN BECOMES THE PM”. The credit list and crew etc. be placed at the end of the film.
- (15) The background music, songs etc. needed for the film would be the responsibilities of the

participants. The Music Director's permission must have been sought for the same.

- (16) All the participants must send the Film posters, Synopsis, Credit List and Crew Member List, separately.
- (17) Entry Form along with rules and regulations, can be downloaded from our website: - (giffindia.org). Send the filled in form and the DVD of the Film to the address of the office.
- (18) The selection round of this competition will be done as Public Poll and then Final Round will be held before the jury to select 10 winners.
- (19) The decision of the jury will be considered as final and undisputable.
- (20) All the rules have been read by me and I would abide by them till the event is over.
